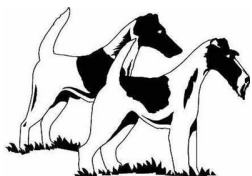

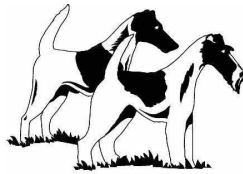

Test Secretary or Judges may modify the running

### **Tests Offered**

Introduction to Quarry (non-regular class, with no credit toward titles),  
Novice Earthdog, Junior Earthdog, Senior Earthdog & Master Earthdog  
All classes are open to all eligible dogs (see Chapter 1, Section 6).

### **Eligible Breeds**

Dachshunds, Miniature Pinschers and the following terrier breeds:  
Australian, Bedlington, Border, Cairn, Cesky, Dandie Dinmont, Glen of Imaal, Jagdterrier, Lakeland, Manchester, Miniature Bull, Miniature Schnauzer, Norfolk, Norwich, Parson Russell, Rat, Russell, Scottish, Sealyham, Silky, Skye, Smooth Fox, Welsh, West Highland White, Wire Fox, and Yorkshire.

Dogs 6 months of age or older that have been either individually registered with the AKC, recorded with the Foundation Stock Service (FSS), registered with a foreign or domestic registry organization whose pedigrees are acceptable for AKC registration, or dogs of an eligible breed that have been granted a Purebred Alternative Listing (PAL/ILP). A dog with and AKC Limited Registration shall be eligible to participate in Earthdog tests, as are spayed and neutered dogs.

Dogs may enter more than one regular class at an Earthdog test provided the dog is eligible for the class as defined in Chapter 3. Bitches in season shall not be eligible to enter the test. All entries must be accompanied by entry fees to be valid.  
No entries will be taken over the phone or electronically.

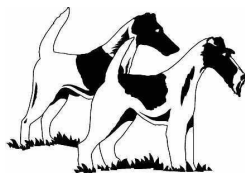

### - - - Notice to Exhibitors - - -

- **The Detroit Beagle Club, Terrier Club of Michigan & Motor Cities Fox Terrier Club will abide by the current Covid-19 mandates of the state of Michigan.**
- You are expected to clean up after your dogs, both at the test and at motels. Please help us keep these good grounds.
- Owners or handlers entering dogs in a test do so at their own risk and agree to assume responsibility for any damage caused by them or their dogs. They also agree to abide by all the Rules and Regulations of the American Kennel Club.
- Barking dogs outside the test area are to be removed from the area but should not be disciplined for barking.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Test Committee, be asked to leave the test site. In such cases, no refund of any fees will be made.
- All dogs present must be on lead or confined to their crates except when being judged.
- Dogs are not permitted to wear collars during judging with the exception of the Master walk up. The den areas for IQ, NE, JE, SE, and ME will be fenced for this test.
- Unsportsmanlike conduct, including rough handling or misconduct of any kind, will result in excusal from the test.
- Entry fees will not be refunded in the event that a dog is absent, disqualified, excused or barred from the test by action of the Test Committee.
- Post Dated or Returned Checks do not constitute a valid entry fee. A \$25.00 service fee will be added for all returned checks.
- Owners are responsible for errors in making out entry forms, whoever makes such errors. No entry fee will be refunded in the event of such errors, or cancellations of entries after the published closing date.

#### Directions to Detroit Beagle Club in Addison, MI

- From Jackson, MI: take I-94 to US127 SOUTH
- US 127S to US12 (about 30 minutes)
- East (left) on US12 to Cement City Highway
- South (right) on Cement City Highway approx. 2 miles
- Beagle Club is on the right side of the road.

### TCM & MCFTC COVID-19 Procedures & Policies:

Please read the following information and allow extra time. **Updates may occur based on changes from the State of Michigan.** The clubs, officials and participants are required to follow state, local and facility guidelines that apply to the area and site that the show is being held. Everyone should wash hands or use hand sanitizer frequently. Avoid shaking hands and any other physical contact. Avoid touching dogs that are not your responsibility.

1. IF YOU ARE ILL, FEEL UNWELL, COUGHING, SNEEZING OR RUNNING A TEMPERATURE: **Please stay home.**
2. Exposure to COVID-19: If you have recently been in the presence of a person who has either tested positive for COVID-19 or has the symptoms (coughing/sneezing/temperature) please stay home.
3. **Bring your own pens, pencils, sanitizer, personal use masks and provide your own scoops and/or poop bags for clean-up. This is a self cleaning event.**
4. Earthdog Sites: To minimize the number of persons near the sites at any one time, be aware of the running order. Do not arrive at your designated location prior to the steward calling you and please exit the area upon completion of your test. Do not congregate near the entrances and exits to the sites.
5. Masks: Per our current state requirements, the wearing of masks is not mandatory. Mask mandates may change by the test dates. Feel free to bring your own masks to stay safe and remember to maintain social distancing!
6. Sanitizers: Wipes, disinfectant spray & hand sanitizer will be available in the clubhouse for club use and frequent cleaning. Please bring your own hand sanitizer and preferred products for personal use.
7. All attendees *may* be required to sign a COVID-19 waiver affirming the above information.
